Bylaw No. 2108 SUBJECT:

Solid Waste Management and Regulation Charges Amendment

## Recommendation/Action:

That it be recommended that CVRD Bylaw No. 3591 - Solid Waste Management Charges and Regulations Amendment Bylaw, 2012 be forwarded to the Board for consideration of three readings and adoption.

Relation to the Corporate Strategic Plan: Responsible waste management - continuing to work towards full implementation of the Solid Waste Management Plan.

Financial Impact: (Reviewed by Finance Division:

Although the CVRD boasts one of the widest selections of recyclables in the Province, we still need to move closer to cost recovery for the recyclable items offered. As an incentive to reduce waste and increase recycling, the tipping fees for asphalt roofing, drywall, and organic waste have historically been priced below the tipping fee for refuse; likewise, if their respective tipping fees are increased, the tipping fee for refuse should also be adjusted to scale. Tipping fee increases, effective May 1, 2012, for the products noted below will result in the following estimated additional annual revenues:

Item	2011 Rate	2012 Rate	Est. Additional Annual Revenue
Refuse:	\$137.00	\$140.00	\$69,500
Asphalt Roofing	\$110.00	\$120.00	\$ 9,090
Drywall:	\$180.00	\$190.00	\$4,700
Organic Waste:	\$95.00	\$100.00	\$ 4,780
TOTAL:			\$88,070

The fee increase for refuse is included in the 2012 budget; however, the other increases were not anticipated until after the budget process.

#### Background:

CVRD Bylaw No. 2108 (Solid Waste Management and Regulation Charges) regulates the disposal of solid waste at CVRD facilities. As well as increasing tipping fees, other revisions to the bylaw are housekeeping items due to changes in the BC Recycling Regulations.

## **COWICHAN VALLEY REGIONAL DISTRICT**

## **BYLAW No. 3591**

## A Bylaw to Amend Bylaw No. 2108 – Solid Waste Management Charges and Regulations Bylaw.

WHEREAS the Board of Directors of the Cowichan Valley Regional District established a scale of charges for its solid waste disposal facilities under the provisions of Bylaw No. 2108, cited as "CVRD Bylaw No. 2108 – Solid Waste Management Charges and Regulations Bylaw, 2000";

**AND WHEREAS** the Board deems it desirable and expedient to revise Section 2 – Definitions and Schedule B – Charges For Solid Waste, Controlled Waste and Recyclable Materials;

**NOW THEREFORE** the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

## 1. CITATION

This Bylaw may be cited for all purposes as "CVRD Bylaw No. 3591 - Solid Waste Management Charges and Regulations Amendment Bylaw, 2012".

## 2. AMENDMENT

- a) That the following revisions be made under Section 2 Definitions:
  - i. The definition for "Engineer" be deleted in its entirety.
  - ii. The definitions for "Lead-acid Battery" and "Used Antifreeze" be deleted in their entirety and replaced as follows:
    - "Lead-acid Battery" means an electro-chemical cell contained in a plastic case consisting of lead and lead oxide plates and containing a sulphuric acid, which is used to supply an electric power source and which is defined under the Recycling Regulation (BC 449/2004), and all amending regulations under the BC Environmental Management Act.
    - "Used antifreeze" means a liquid, such as ethylene glycol or alcohol, that may be mixed with water and has been used as a radiator fluid, but does not contain lubricating oil or petroleum products and is defined under the Recycling Regulation (BC Reg. 449/2004) and all amending regulations under the BC Environmental Management Act.

iii. The following definitions be added:

"*Manager*" means the General Manager, Engineering & Environmental Services Department of the *CVRD*, or his authorized designate.

"Used Antifreeze Containers" means containers that hold antifreeze and which are defined under the Recycling Regulation (BC Reg. 449/2004), and all amending regulations under the BC Environmental Management Act.

- iv. The following items be added under "Controlled Waste" and "Recyclable Materials":
  - Used antifreeze
  - Used antifreeze Containers
- b) That Schedule B to Bylaw No. 2108 be deleted in its entirety and replaced with Schedule B attached hereto and forming part of this Bylaw.

- 2. The charge for depositing **Solid waste** that is not **Source-separated waste** at the **Disposal facility** is as outlined in Section 5 of this bylaw.
- 3. In the event that the scales provided are not operational, or in the event of traffic congestion, or at the discretion of the *Engineer*, weights of *Loads* and *Small loads* shall be as estimated by the *Engineer* and a fee shall be charged as outlined in Section 1 above.
- 4. Where the charge for depositing **Solid waste** at the **Disposal facility** is described under Section 4 of this bylaw, the charge payable shall be paid following the weighing of the empty **Vehicle** after the load is deposited and shall be based on the difference in weight between the loaded weight and the weight of the empty **Vehicle**.
- 5. Notwithstanding Section 5 hereof, any person depositing Solid waste at the Disposal facility on a regular basis may apply in writing to the CVRD for credit and if the Treasurer is satisfied of the credit worthiness of the person, he or she may grant credit to that person, in which case payment of the charge imposed under Section 4 shall be made and the credit extended on the conditions of the application.

SUBJECT:

Maximum Requisition Limit Increase - Sentinel Ridge Sewer System

## **Recommendation:**

That it be recommended to the Board that a bylaw be prepared to amend "CVRD Bylaw No. 2790 – Sentinel Ridge Sewer System Service Establishment Bylaw, 2006", to increase the maximum requisition from \$42,400 to \$53,125, and that the amendment bylaw be forwarded to the Board for consideration of three readings and adoption.

Relation to the Corporate Strategic Plan: Provides a reliable essential service.

Financial Implications: (Reviewed by Finance Division:

The annual cost of providing this service is recovered by user fees and parcel tax. The maximum parcel tax requisition for the Sentinel Ridge Sewer System was amended in 2011 and is currently \$42,400.00. Raising the maximum requisition will allow the CVRD to collect the necessary amount of parcel tax in 2013 for the expanded service area.

The maximum requisition limit increase is <u>above</u> the allowable <25% over a five year period as set out in Section 801 of the Local Government Act; however, due to the expansion of the service area, the CVRD needs to collect greater revenue for the entire system without raising the individual rates to existing homeowners. In fact, since 2007, as the service area has expanded and more homes have been constructed, the requisition limit has climbed from \$34,000.00/year to \$42,400.00/year, but the individual parcel taxes have decreased from \$522/year to an anticipated estimate of \$425/year in 2013.

#### **Background:**

From its inception, the Sentinel Ridge subdivision was a multi-phased development with capacity for additional growth from adjacent developments such as the Mill Bay Marina, Hidden Hills and Malahat properties. As the phases of each development are added to the service area, there can be anywhere from a 25% to 100% increase in the total number of lots within subdivision. The result of this is often that the individual user rates will go down, but due to the increase in the number of overall of lots, the net amount of parcel tax collected will proportionally go up.

To limit the Regional District's ability to raise the parcel taxes without consulting or getting the consent of the electorate, the Local Government Act regulates the amount of this increase to <25% over a 5 year period. Any increases greater than this amount requires that the Local Government get approval from the residents. The intent of this is to allow the rates to be increased moderately for things such as electricity, materials, supplies, etc., without having to go to the residents for approval. The unique aspect of what we are seeing in the CVRD is that the phases of a number of developments are growing and expanding at a much faster rate than most, requiring us to raise the total requisition limits without increasing the rates to individual users.

SUBJECT: Mill Springs Sewer System Engineering Assessment

### Recommendation:

That the engineering assessment of the Mill Springs Sewer System, carried out by Kerr Wood Leidal, be funded by an additional \$4000 from the CVRD Electoral Feasibility Studies fund, and repaid upon establishment of a Mill Springs Sewer Function.

Relation to the Corporate Strategic Plan: Provides a reliable essential service.

Financial Impact: (Reviewed by Finance Division:

Monies from the Electoral Feasibility Studies Fund of up to \$9000 will be repaid upon establishment of a function for the Mill Springs Sewer System. The 2012 budget includes \$66.800 for such consultant fees.

## **Background:**

The following resolution was ratified by the CVRD Board on December 8, 2010:

"That the CVRD support application of an infrastructure planning grant to carry out an engineering assessment on the Mill Springs Sewer System, to be funded to a maximum cost of \$15,000, with \$5,000 from the CVRD Electoral Feasibility Studies Function and \$10,000 through the Provincial Infrastructure Planning Grant Program"

As a grant was not awarded through the Provincial Infrastructure Planning Grant Program, the assessment was partially funded with \$13,292 from the Mill Springs developer and \$5,000 from the CVRD's Electoral Feasibility Studies Function. However, due to the complicated nature of the feasibility study, costs for the completed report were over budget and staff are now requesting that an additional \$4,000 be provided from the Electoral Feasibility Studies Fund, to be repaid upon establishment of a CVRD function for the Mill Springs Sewer System.

Critical Location Streetlights – Electoral Area C – Cobble Hill

### Recommendation:

That it be recommended to the Board that two critical location streetlights be installed at the following locations in Electoral Area C:

- Intersection of Cobble Hill Road and Fisher Road 1.
- Intersection of Cobble Hill Road and Empress Avenue 2.

Relation to the Corporate Strategic Plan: Safe and healthy community.

Financial Impact: (Reviewed by Finance Division.

Annual operating costs will be approximately \$228.00 for each light (\$19.00 per month) and BC Hydro installation costs amount to \$934.08. Although these costs were not anticipated in the 2012 budget, the budget can accommodate the extra expense.

#### **Background:**

The CVRD Critical Location Street Lighting Policy states "That upon written request, and subject to BC Hydro and Committee approval, a singular streetlight be installed at critical intersections and sites for safety reasons in areas such as transit stops, hazardous intersections, schools, community and regional parks, and cluster mailboxes". The written request must include signatures on a petition from area residents. In this case, the Electoral Area Director has put forward a request due to several concerns raised by residents. Installation of these lights has also been endorsed by the R.C.M.P., as both locations are on a busy road with poor night time visibility.
