On behalf of the CVRD Regional Agricultural Advisory Commission and the CVRD Board of Directors we wish to express our support for the Cowichan Exhibition's Sunfest Country Music Festival event held at 7380 Trans Canada Highway, Duncan, BC.

The Cowichan Region is one of the major agricultural areas on Vancouver Island, encompassing 55,586 ha of land suitable for agriculture. With over 600 farms in the region, agriculture is an important economic sector generating gross farm receipts of \$47,554,455. Local food production is an important component of the 100 Mile Diet concept and helps to address the issue of food self-sufficiency. The industry is not without its challenges. Agriculture production in the region has declined in recent years and the need to educate, promote and support agriculture has never been greater.

The Cowichan Exhibition Park is the host venue for many agricultural activities throughout the year and raises the awareness of agriculture in the Cowichan Region. Agricultural Land Commission Referral Body

Recommendation/Action:

That only matters that relate directly to the action items within the CVRD Area Agricultural Plan or referred by the Electoral Area Service Committee (EASC) or the Cowichan Valley Regional District Board of Directors will be considered for discussion and/or comment by the Regional Agricultural Advisory Commission (RAAC).

Background:

At the RAAC meeting dated May 28, 2013, the following motion was carried:

It was moved and seconded that staff prepare a report to the Regional Agricultural Advisory Commission to explore feasibility and suitability of the Regional Agricultural Advisory Commission being a referral body for the Agricultural Land Commission within the Cowichan Region.

Staff understands this motion was passed with the intent of reviewing the possibility of having all Agricultural Land Reserve (ALR) applications from Electoral Areas and Municipalities referred to the RAAC for comment prior to submission to the Agricultural Land Commission (ALC) for a final decision.

Bylaw No. 3515, to establish a Regional Agricultural Advisory Commission for the Cowichan Valley Regional District clearly defines the responsibilities of the Commission:

- a) Implement the CVRD Area Agricultural Plan and the recommendations contained in that Plan. More specifically to:
 - Review all 78 recommendations;
 - Identify those activities already underway and identify the groups and organizations undertaking those activities;
 - Ensure that sufficient resources are available to accomplish activities and if required, identify the additional resources needed;
 - Prioritize activities to be undertaken:

- Identify the activities that have not been addressed and prioritized;
- Identify the necessary resources to complete those activities; and
- Make recommendations to the CVRD to allocate resources to accomplish those activities.
- b) Advise the Board on issues of importance to the agricultural community, and on ALR exclusion applications, ALR subdivision applications and change of use applications as referred by the Electoral Area Services Committee as well as any other matters referred to it by the Board.
- c) Subject to the provisions otherwise contained in this bylaw, provide the Board with advice by way of:
 - (i) Matters which may legally or financially bind or commit the Board.
 - (ii) Provide input to an annual financial plan which will be become a specific Economic Development Agriculture Project in the annual Function 121 budget.
 - (iii) Quarterly progress/status reports to the Board.

The current bylaw provides a mechanism for the RAAC to respond to ALR exclusion applications, ALR subdivision applications and change of use applications within the nine electoral areas. The four municipalities are not included as each municipality makes their own decisions on land use in their area. It would not be appropriate for the RAAC to make comment or recommendations outside of the CVRD jurisdictional boundaries unless requested by EASC or the CVRD Board.

The Agricultural Land Commission (ALC) has a legislated process (Agricultural Land Commission Act) for dealing with land use issues in the Agricultural Land Reserve. Applications regarding land use changes within the ALR are dealt with by the ALC and the affected local government. The ALC may refer the application to various other agencies, however, this is at the discretion of the ALC.

The responsibilities of the RAAC are ambitious and there is much work to be done. Additional activities for the RAAC should only be considered after the current responsibilities are fulfilled.

The RAAC is supported by the Economic Development Division staff whose role is to provide economic development services for the CVRD. Staff resources are extremely limited and including additional items for consideration would take away from the RAAC responsibilities as set out in Bylaw No. 3515.

Regional Agricultural Advisory Commission Sub-Committee #2 Report re: Incubator Farm Program May 16, 2013

In attendance: Mary Marcotte, Rob Hutchins, Gerry Giles, Dan Ferguson, Judy Stafford, Kathy Lachman

At the April 23, 2013 Regional Agricultural Advisory Commission meeting, the following recommendation was passed:

It was moved and seconded that the item of supply and demand along with the discussion of incubator farms be referred to Subcommittee 2 for review and report back to the Commission.

Sub-committee #2 met to discuss this one agenda item. Dan Ferguson noted that at the last Cowichan Agricultural Society meeting, there was 80% support to send a letter of support to the RAAC supporting an Incubator Farm Program. The sub-committee agreed that educating farmers was the prime purpose of an Incubator Farm program and decided to move ahead.

It was moved and seconded that sub-committee #2 recommends moving forward in supporting the development of an Incubator Farm initiative. Passed.

Note: Due to a conflict of interest, Judy Stafford left the meeting.

The sub-committee discussed the RFP that staff developed to explore the feasibility of an Incubator Farm Program and develop the program components and budget. The following motions were made and passed:

It was moved and seconded to request the CVRD Planning and Development Department to develop the Incubator Farm Program as per the RFP for the Regional Agricultural Advisory Commission and complete the document within six weeks.

It was moved and seconded that if the CVRD Planning and Development Department is not able to accommodate the request within the time frame, the RFP as circulated will be tendered.
