2. APPROVAL OF PREVIOUS MINUTES – *Motion*: To approve the amended minutes from the September 12, 2016 Meeting: Dave Key. Carried.

3. OLD BUSINESS -

- **3.**1 Chemainus Road Use Data Jackie presented Brian F with a data package that spanned June 9, 2016 to August 28, 2016. Not only were cyclists and pedestrians logged, but vehicles were counted as well. Data to be used by CVRD staff for grant applications.
- **3.2** 3835 Gardner Road West Proposed Subdivision follow-up from September 12, 2016, meeting that no further input was received by the Chair. Therefore, the recommendation from the Parks Commission remains to support that CVRD accept the 5% cash alternative for 3835 Gardner Road West proposed subdivision.
- **3.3** Stocking Creek Park Main trail (Kon Trail) two seasonal boggy sections still require remediation by CVRD trail staff:

Action: Will be reviewed in the context of the larger issue of gravel and wood chip surfacing of trails.

- **3.4** Centennial Park Awaiting estimate from CVRD for drainage plan between the picnic and concession building on the field. Considered under the Budget Presentation.
- **3.5** Centennial Park Awaiting information from CVRD for deep tining the playing fields in fall 2016. Consider in the spring 2016.
- **3.6** Stuart/Clifcoe Connector A CVRD Parks staff person to meet with a contractor regarding the need for a small drainage channel to prevent trail erosion. **Action:** Ongoing liaison to occur between CVRD staff and Greg Taylor. **3.6** Signage at Centennial Park: **Action**: Brian Farquhar will follow up on the posting of "No Smoking" bylaw signage.

- **5.4** Diana Princess of Wales Park Brian discussed that CVRD staff have visited some Saltair trails and believe that leaf blowing didn't cause erosion. They feel that poor trail infrastructure could be the cause. New Trail Guidelines are being developed by the CVRD.
