CAPITAL PLAN PROJECTS QUARTERLY REPORT Q3 2024

REPORT BACKGROUND

The purpose of the Capital Plan Project Report is to inform the Board of the progress toward completing major Capital Projects approved for the budget year. Capital Projects are financed from a variety of sources, including: grants, borrowing, requisition and transfers from reserve, and can extend beyond one year for large projects.

All Capital Projects are included in the budget and were approved during budget deliberations, budget amendments, or carried forward from the previous year's budget.

Projects are considered to be on track if progress is occurring at the expected rate, even if they are expected to take beyond one year to complete. Any projects unfinished at the end of the budget year will be carried forward to the next year's budget and reflected on subsequent reports until completion.

As staff have not reported on the progress of major Capital Projects since Q4 2022, the Capital Plan Projects – Q3 2024 Status Report includes updates on projects from this previous reporting period. Staff are presenting this report to the Board, in its new format, for information.
